No. 31485—FIN-PUIF-MEET-0007/2014—In exercise of the powers conferred by Section 18 of the Odisha Protection of Interests of Depositors (in Financial Establishments) Act, 2011 (Odisha Act 21 of 2013), the State Government do hereby make the following Rules further to amend the Odisha Protection of Interest of Depositors (in Financial Establishments) Rules, 2013, namely :—

(1) These Rules may be called the Odisha Protection of Interests of Depositors Financial Establishments) (Amendment) Rules, 2015.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Protection of Interest of Depositors (in Financial Establishments) Rules 2013, in Rule 7, for sub-rule(3), the following sub-rules shall be substituted, namely :—

“(3) The sale of property by public auction under sub-section (6) of Section 9 of the Act shall be done by fixing an upset price of the property by a Committee under the Chairmanship of Sub-Collector of the area in which the property is situated with the following members, namely :—

The Competent Authority shall send the list of properties for public auction to the Collector of the district in which the property is situated, with a request to fix the upset price by the Committee constituted for the purpose in an expeditious manner. The Chairman of the Committee may co-opt any other officer depending on the nature of the property as a Member of the Committee for fixing the upset price and the upset price so fixed by the Committee shall be approved by the Collector of the concerned district.

(4) The Competent Authority on whom a direction is made by the Designated Court under sub-section (6) of Section 9 shall conduct the physical sale of the property by public auction and realise the sale proceeds and credit the same to an account opened in a Scheduled Bank for the purpose and intimate the same to the Designated Court.”

The IDWG will be responsible for :—

- (a) Day-to-day co-ordination and management of the scheme activities within the State
- (b) Co-ordinating agency among all the Ministries/Departments/Agencies/Research/Financial Institutions engaged in creation/use/recycling /conservation of water to bring them together under a single platform to take a comprehensive and holistic view of the entire water-cycle so as to ensure that each drop of water is put to the best possible use.
- (c) Scrutinising/prioritising the project proposals/DPRs in coformity with the guidelines and that they emanate from SIP/DIPs, besides being consistent with technical standards & financial norms.

IDWG will further examine and ensure that :—

- (a) Funds available under other schemes of the State Government and/or Government of India for the proposed projects have been accessed and utilized/planned for utilization before they are brought under the PMKSY ambit.
- (b) PMKSY projects/activities should not create any duplication or overlapping of assistance/ area coverage *vis-a-vis* other schemes/programmes of State/Central Government.
- (c) PMKSY funds are not being proposed as additional or 'top-up' subsidy to other ongoing schemes/programmes of State/Central Government excepting for topping up of material cost beyond the approved limit of the respective schemes like programmes (material component is restricted of the 40% of the exact cost under MGNREGS).
- (d) DPRs have included provision for monitoring and evaluation
- (e) Convergence with other State/Central Schemes has been attempted.

The State Level Sanctioning Committee (SLSC) under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) will, *inter alia*, also be responsible for—

- (a) Approving the State Irrigation Plan (SIP) and District Irrigation Plan (DIP)
- (b) Sanctioning and prioritizing funding of projects under PMKSY
- (c) Monitoring and reviewing implementation of PMKSY
- (d) Ensuring convergence with other schemes and that no duplication of effort or resources takes place.
- (e) Ensuring that there are no inter-district disparities with respect to the financial patterns/ subsidy assistance in the projects.
- (f) To decide the implementing agency/Deptt. in the State for particular project depending on the nature of the project and expertise available with the agency/Department.
- (g) Ensuring that the programme implementation in accordance with guidelines laid down by the concerned programme component Ministry/Department.
- (h) Initiating evaluation studies from time to time, as may be required
- (i) Ensuring that all extant procedures and instructions of Government of India are followed so that the expenditure incurred on implementation of the projects is barest minimum with due concern for economy in expenditure and also in conformity with the canons of financial propriety, transparency and probity.
- (j) To ensure that Panchayati Raj Institutions (PRI) are actively involved in implementation of PMKSY, especially in selection of beneficiaries, conducting social audit, etc.

No. 10432—SYS-SPW-SPW-006/2015-S&YS.—This to notify that the guideline of Odisha Sports Development fund, created in 2012-2013 by the State Government in Sports & Youth Services Department, hereby stands revised with effect from the date of this Notification.

The revised guideline is given below :

**GUIDELINE OF ODISHA SPORTS DEVELOPMENT FUND**

(Revised with effect from the date of this Notification)

**01. Objective :**

The objective of creation of Odisha Sports Development Fund (OSDF) is to supplement and complement the mandated activities of Sports & Youth Services Department by way of providing required financial resources in case of inadequate budgetary provision or in absence of budgetary provision in the S&YS Department for a desired activity.

**02. Constitution of the Fund :**

The OSDF shall consist of contributions received from various Companies, Organizations, Individuals, Association of Individuals, etc. from time to time. However, there shall be no budgetary support from the State exchequer for the fund.

**03. Custodian of the Fund :**

The Department of Sports & Youth Services shall be the custodian of the fund. As per Rule 5 of the O.G.F.R, Vol.-I, a separate Bank Account shall be opened in a Scheduled Commercial/Nationalised Bank in Bhubaneswar by the S&YS Department for OSDF. The D.D.O. of the S&YS Department shall be the Drawing & Disbursing Officer to operate the OSDF Bank Account.

**04. Management of the Fund :**

Management of the fund, i.e. decision regarding utilization of the fund from time to time, shall be made by the Sports & Youth Services Department, with approval of the Minister of the Department in strict conformity with "Odisha General Financial Rules" as amended from time to time. However, the Minister of the Department shall be competent to delegate some of his power and authority to the Secretary of the Department in case of need, as per delegation of Financial Power Rules, 1978 of Government of Odisha as amended time to time.

**05. Accounting and Audit :**

5.1 An acknowledgement slip shall be given to each donor on receipt of contribution to the fund.

5.2 A separate Cash Book shall be maintained by the D.D.O. of the S&YS Department for OSDF. The Cash Book is to be reconciled with the Bank Passbook from time to time.

5.3 Separate *pro forma* account to be maintained in case of contributions received for specific purposes.

5.4 Annual Account to be prepared at the closure of a Financial Year covering the transactions and Balance Sheet at the end of Financial Year.

5.5 Copy of the annual account along with the audit report (audited by Internal Auditors) & Auditor-General to be prepared at the end of each Financial Year.

5.6 The fund shall be open to audit by the State Government as well as the CAG.

#### 06. Reporting :

Details of receipt and expenditure of the fund shall be included in the Annual Activity Report of the Department and will also be intimated to all donors of that particular year. It shall also be hosted in the S&YS Department website for public view.
