Subject—Guideline for Granting No Objection Certificates to Physiotherapy Institutions for conducting Bachelor Degree of Physiotherapy Course (BPT) in the State.

(a) "Physiotherapy" means a health care profession which includes assessment, examination, interpretation, diagnosis, planning and implementing treatment plan and rehabilitative programs that improve or restore human motor functions, maximize movement ability, relieve pain syndromes, prevent and treat physical challenges associated with injuries, diseases and other impairments using broad range of physical therapies and techniques, but not limited to exercises, mobilization, manipulation, mechanical and electrotherapy modalities, activities and devices.

Due to non-availability of any regulatory mechanism for such course, no objection certificates were granted in a subjective manner. In order to obviate the difficulties, Government, after careful consideration, have been pleased, to frame the following indicative minimum standards for an institution up to 40 in take capacity to conduct the course in the State.

1. APPLICATION

Any person/institution/trust/society, who has established an institution before the date of this resolution or intending to open new college/course from the academic year 2016-17 onwards shall seek the permission of the State Government for issue of no objection certificate within a period of two months from the date of issue of this resolution. They must apply in prescribed application format as in Annexure-A to Director of Medical Education and Training (DMET), Odisha, along with the minimum requirements available and the inspection fee of Rs. 60,000 (Rupees sixty thousand) only for in shape of Bank Draft drawn in favour of DMET, Odisha.

2. INSPECTION

On receipt of such an application, the Team of Inspectors will inspect the institution where BPT is imparted or will be imparted to assess the minimum requirements available, suitability of the institution for the purposes of training and on the adequacy of the training therein for such course. On the basis of such report, Govt. may consider issue of NOC.

The Team of Inspector shall consists of following members, provided that no expert shall belong to the same institute for which inspection is to be made and one physiotherapist of repute shall be a member of the inspection team—

- (i) The DMET or any officer authorised by him
- (ii) The senior-most Professor of a Govt. Medical College and Hospitals of the State from Orthopaedics or Neurology Department.
- (III) One Professor of Physiotherapy from any speciality/Director, RSIC, Cuttack/Physiotherapist from SVNIRTAR in the grade of HoD.

3. LAND & BUILDING

The applicant institution should have a separate land and building for Physiotherapy training and clinical services, having adequate scope for expansion. Such building should have adequate space and should have out-patient department, laboratories, office space, class rooms, hostel and other ancillary facilities. The inspection team shall indicate specifically about the adequacy of the space in their report. The following requirements are to be met—

(i) Minimum built-up area prescribed is 20,000 sqft.

9. ELIGIBILITY AND ADMISSION OF STUDENTS—

Sc. examination (or equivalent) having English as a subject and a minimum of 50% marks in Science with Physics, Chemistry, Biology as mandatory subjects. For S.C./S.T. and Physically Handicapped candidates, the minimum mark shall be 40% and 45% respectively. In case no reserve candidate is available, the vacancies will be filled up by unreserved candidates.

The selection of candidates by centralised admission and counselling to this course shall be guided as per sub-section (u) (xii) of Section 2 of O.P.E.I. Act, 2007 and rules and any other Act, Rules or Guidelines, as may be notified by the Govt. from time to time.

Admission to such Institutes shall be through OJEE/other authority designated by Govt. and shall also follow the fees structures so prepared.

10. INTERSHIP—

Internship of the students and their remuneration for the period shall be made by the institute of internship.

11. PERMISSION—

Permission to start the course may be issued by the Government if the institution satisfies all the norms and conditions after due verification of the same by the inspection team and with specific remarks of the Director of Medical Education and Training.

12. SHIFT OF STUDY CENTRE—

Institute so permitted to conduct the courses will be allowed to shift /change of study centres only after completion of three (3) years from the date of actual commencement of the course by the first batch of students after getting orders of Government on reinspection of the centre.

13. ACADEMIC CONTROL—

The BPT Colleges so established will be under the Academic control of the DMET until the State Council (Odisha Physiotherapy Council) is formed. Periodical review and a system of inspection as a means of quality control will be made by the DMET and all his recommendations shall be carried out immediately otherwise the Government reserves the right to withdraw the permission.

14. EXISTING INSTUTIONS—

Any person/Institution/Trust/Society, who has already established an institution before the date of the publication of this Resolution will have to accomplish the minimum requirements to continue from the Academic Year 2016-17. No admission shall be made by them until then.

15. LIABILITY—

There shall not be any liability of any form on the part of Government for conducting the course or pursuing it by anybody. In the event of the closure of the Institute/College by whatever name called, there shall not be any responsibilities or obligation on the Govt. to either take over the Institute or admit students to Govt. Institutions.

Subject—After careful consideration, the Government of Odisha is pleased to introduce a "Self Certification Scheme" for the factories established in the State for "Ease of Doing Business".

- 1. Objective:—This Scheme aims at making the occupier conscious and truthful as a law abiding person willing to take care of the interest of the workers by complying with the provisions of the Factories Act, 1948.
- 2. Applicability:—This Self Certification Scheme shall be valid for all the factories coming under the Factories Act, 1948 and Rules made thereunder, except the factories covered under Section 2 (cb) and Section 87 of the Factories Act, 1948 and Rules framed thereunder and factories classified as MAH category as per The Orissa Factories (Control of Major Accident Hazard) Rules, 2001.
- 3. Procedure for joining the Scheme:—The scheme will be optional and the occupier of any factory intending to adopt this scheme shall apply in duplicate to the Director of Factories and Boilers, Odisha with a copy to the Deputy Director, Factories & Boilers of concerned Division and also to the Asst. Director of Factories and Boilers of the concerned zone in the *pro forma* in Form-I along with the documents in detail. The occupier is also required to produce an Affidavit in the format in Form-II. Any discrepancy in the application or enclosures shall be communicated to the applicant within 30 days from the date of receipt of the application in the Office of the Directorate of Factories and Boilers.

to 15th February every year commencing with the succeeding year till expiry of the scheme.

If no discrepancy is so communicated, the applicant shall be deemed to have been enrolled under the Self-Certification Scheme.

4. Filing of Return:—After being enrolled under the Self-Certification Scheme, the concerned occupier shall file the Self-Certification Return in the prescribed Pro forma in Form-III in duplicate to the Director, Factories & Boilers. The return shall be filed on any working day between 15th January

5. Validity of the Scheme:—The Scheme shall be valid till it is withdrawn or cancelled. The occupier shall file combined Annual Return in Form 21 of the Odisha Factories Rules, 1950 during the validity of Scheme. In the event of any fatal accident, the validity of the scheme will automatically cease to continue and the occupier has to apply afresh to the authorities to join the scheme.

6. Option for quitting the Scheme:-If any occupier wants to quit the scheme, he can do so at any time by giving one month's prior notice.

7. Penalty for submitting false information or violating the provision of the Scheme:—If it comes to notice of Director, Factories and Boilers that the applicant has given false declaration or found not complying with provisions of the statute, legal action shall be initiated against the occupier and manager of the factory as per the provisions of Factories Act, 1948.

8. Inspection Procedure:—Twenty per cent (20%) of the factories so covered under the "Self-Certification Scheme" shall be selected at random for inspection once in a year to verify proper implementation of the provisions of Factories Act and Rules made thereunder. However, in case of any accident or dangerous occurrence or specific complaint, inspection shall be carried out as per the provisions of Law.

This Resolution shall come into effect from the date of publication in the *Odisha Gazette*.
