#### RESOLUTION

The 2nd May 2018

Pursuant to the direction of the Hon'ble Supreme Court dated the 27th March 2018 in W.P.(C), No. 643 of 2015, (All India Judges Association–*vrs*-Union of India & others), the State Government do hereby implement the recommendations of the Second National Judicial Pay Commission and as follows:—

- 1. Interim relief to the extent of 30% of increase in basic pay with accrued increments shall be paid to all categories/ranks of judicial officers with effect from the 1st January 2016.
- 2. The said increase in pay shall be treated as a separate component and no D.A. is payable thereon.
- 3. Arrears shall be worked out with effect from the 1st January 2016 on the above basis. The details of calculations are set out in *Annexure-1*.
- 4. On the same basis, the interim relief shall be provided to the pensioners and family pensioners with effect from the 1st January 2016 and the arrears to be paid accordingly.
- 5. Wherever the benefit of interim relief has already been granted, the judicial officers in those State /UTs can exercise their option to continue to be governed by such orders.
- 6. The amounts payable by way of interim relief now proposed are liable to be adjusted against the future determination pursuant to the final report submitted by the Commission.

7. The said interim relief as recommended by the Commission shall be implemented with effect from the 1st May 2018 and arrears payable pursuant to the said recommendations as mentioned at Para. 3 shall be paid on or before dated the 30th June 2018.

This has been concurred in by Finance Department on the 20th April 2018 in OWSAS File No. LAW-JUDI-COMSN-0001-2018.
