#### NOTIFICATION

The 11th July 2017

No. 5467—LL-II-FM-22/2008-LESI.—The following draft of certain rules further to amend the Odisha Factories Rules 1950, which the State Government propose to make in exercise of the powers conferred by Section 112 of the Factories Act, 1948 (63 of 1948) is hereby published as required by Section 115 of the said Act, for information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration by the State Government on or after the expiry of a period of forty-five days from the date of publication of this notification in the *Odisha Gazette*.

Any objection or suggestion which may be received from any person in respect of the said draft before expiry of the period so specified above will be considered by the State Government.

#### DRAFT

- (1) These rules may be called the Odisha Factories (Amendment) Rules, 2017.  
(2) They shall come into force on the date of their publication in the *Odisha Gazette*.
- In the Odisha Factories Rules, 1950 (hereinafter referred to as the said rules) in Rule 4 after the words “grant of license”, the following words shall be inserted namely “ with an option to apply for one year term or five years term or ten years term licence”.
- In the said rules, in Rule 5, after a sub-rule (1), the following sub-rule shall be inserted, namely :—  
“(1-a) A licence for five years or ten years term shall be granted in Form No. 4A by the Chief Inspector on payment of five times or as the case may be ten times of the licence fee in vogue”.
- In the said Rules, after Form 4A, the following form shall be inserted, namely :—
