No. 3631—IV(Coal) SM-52/2016-SM.—The following notification issued by Government of India, Ministry of Coal, New Delhi on the 30th March 2017 is hereby re-published in the *Odisha Gazette* for information of general public and all concerned.

(Copy of Government of India, Ministry of Coal Notification dated the 30th March 2017 on Land Acquisition).

S.O.1047(E).—Whereas by the notification of the Government of India in the Ministry of Coal Number S. O. 4099(E), dated the 20th December, 2016 issued under sub-section (1) of Section 4 of the Coal Bearing Areas (Acquisition and Development) Act, 1957 (20 of 1957) (hereinafter referred to as the said Act) and published in the Gazette of India, Extraordinary, Part II, Section 3, sub-section (ii), dated the 21st December, 2016, the Central Government gave notice of its intention to prospect for coal in 1192.293 hectares (approximately) or 2946.156 acres (approximately) of the lands in the locality specified in the Schedule annexed to that notification;

And whereas, the Central Government is satisfied that coal is obtainable in a part of the said lands prescribed in the Schedule appended to this notification.

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 7 of the said Act, the Central Government hereby gives notice of its intention to acquire the land measuring 1192.2930 hectares (approximately) or 2946.1560 acres (approximately) and all rights in or over the said lands described in the Schedule appended hereto :

Note 1 : The plan bearing number OMC/Project/Section-07/16/05, dated the 17th December, 2016 of the area covered by this notification may be inspected in the Office of the Collector, District Angul (Odisha) or in the Office of the Coal Controller, 1, Council House Street, Kolkata-700001, or in the Office of the Chief General Manager (Mining), Odisha Mining Corporation Limited, OMC House,

Bhubaneswar-751 001 (Odisha) or in the Office of the Regional Manager, Odisha Mining Corporation Limited, Baitarni-West Coal Project, At Bhubaneswar (near Pitabali Temple), Post Office Parang, District Angul, Odisha.

Note 2 : Attention is hereby invited to the provisions of Section 8 of the said Act which provides as follows :—

Objection to acquisition :

"8. (1) Any person interested in any land in respect of which a notification under Section 7 has been issued, may, within thirty days of the issue of the notification, object to the acquisition of the whole or any part of the land or any rights in or over such land.

Explanation.—It shall not be an objection within the meaning of this section for any person to say that he himself desires to undertake mining operation in the land for the production of coal and that such operations should not be undertaken by the Central Government or by any other person.

(2) Every objection under sub-section (1) shall be made to the competent authority in writing, and the competent authority shall give the objector an opportunity of being heard either in person of by a legal practitioner and shall, after hearing all such objections and after making such further inquiry, if any, as he thinks necessary, either make a report in respect of the land which has been notified under sub-section (1) of Section 7 or of rights in or over such land, or make different reports in respect of different parcels of such land or over such land, to the Central Government, containing his recommendations on the objections, together with the record of the proceedings held by him, the decision of that Government.

(3) For the purposes of this section a person shall be deemed to be interested in land who would be entitled to claim an interest in compensation if the land or any rights in or over such land were acquired under this Act".

Note 3 : The Coal Controller, 1, Council House Street, Kolkata-700001 has been appointed by the Central Government as the competent authority under Section 3 of the said Act, vide Notification Number SO. 3686(E), dated the 7th December, 2016, published in part II, Section 3, sub-section (ii) of the Gazette of India dated the 9th December, 2016.
