  - (i) The Rules of Business shall be suitably amended by the General Administration Department, enabling handing over the administration of +2 Junior Colleges to School & Mass Education Department.
  - (ii) All the teaching staff, including Junior and Degree Lecturers presently working in Junior Colleges shall be deemed to be on deployment to School & Mass Education Department for a period of one year initially. Simultaneously School & Mass Education Deptt. shall create equal number of PGT posts against the current sanctioned strength of 1023 Junior Lecturers and take steps for their recruitment within a year. Upon the joining of new recruits after due recruitment process, the Junior/Degree Lecturers working on deployment to School & Mass Education Department shall get reverted to Higher Education Deptt. to work against the existing vacancies in Degree Colleges. This will include Government College Lecturers, as well as the Aided College Lecturers, i.e. those covered under GIA or Block Grant, as the case may be.

- (iii) The present infrastructure wherein Junior Colleges are functioning on a shared basis at present shall continue to be shared till the new separate infrastructure is created by School & Mass Education Department.
- (iv) The budget provision for Salary and GIA of the Junior Colleges, so handed over to School & Mass Education Department shall continue to be provided by Higher Education Department for the financial year 2016-17. However, any additional requirement shall be proposed under School & Mass Education Department.
- (v) The admission to all the streams of +2 courses including Vocational and Sanskrit Streams shall be handled by SAMS Society of Higher Education Department for the Academic Session 2016-17.
- (vi) The Council of Higher Secondary Education, along with its Regional Offices shall be transferred to the Administrative Control of S. & M. E. Department.
- (vii) The administration of management of all Private Aided and Non-Aided +2 Colleges including High Power Committee for grant of recognition, formation of Governing Body etc. shall stand transferred to School & Mass Education Department with effect from Academic Session 2016-17.
- (viii) The entitlement of private college teachers for their career advancement shall remain unaffected by such transfer of jurisdiction of Junior Colleges to School & Mass Education Department.
- (ix) All the cases relating to +2 Colleges pending in different Courts i.e OAT, Education Tribunal, High Court and Apex Court etc. will continue to be handled by the Higher Education Department. New cases that may arise after the separation shall be handled by the School & Mass Education Department.
