No. 8116—CONF-II-VII-PS-40/2007—Whereas the "Departmental Proceeding" was drawn up against Shri Naib Naik, Choukidar, office of the District Fisheries Officer-*cum*-C.E.O., FFDA, Mayurbhanja vide this Office Order No. 15366, dated the 23rd September 2006 for unauthorized absence for more than 5 years with effect from the 5th June 1997 & submitting joining report on the 5th May 2005 & again on the 9th May 2007.

And whereas Dy. Director of Fisheries (SBW), Cuttack & Dist. Fisheries Officer, Mayurbhanja was appointed as Enquiring Officer & Presenting Officer respectively vide this Office Order No. 7014, dated the 17th April 2007.

The Enquiring Officer submitted the enquiry report vide his Letter No. 25, dated the 24th October 2007 with the following recommendation :—

(a) Warning not to avail leave without application & permission

(b) Two annual increments be stopped with cumulative effect

(c) The period of unauthorized leave be treated as leave without pay

The matter was moved to Government in Fisheries & ARD Department vide this office Letter No. 10586, dated the 13th July 2009 for final decision of Government on acceptance of joining report of Shri Naik, Choukidar with recommendation of Enquiring Officer.

After careful consideration of all connected records/documents, the Government of Odisha, Fisheries & ARD Department have communicated the decision vide their Letter No. 11440, dated the 9th November 2012, that the case of Shri Naib Naik, Choukidar regarding unauthorized absence beyond five years & his joining in Government duty does not deserve consideration at Government as it is not in accordance with law.

Thereafter 1st and 2nd show cause notice issued in favour of Shri Naib Naik, Choukidar informing that, he is no more in Government service vide this office Letter No. 910, dated the 18th January 2013 & Letter No. 7322, dated the 7th May 2014 respectively & also allowed one month time to appear before Director of Fisheries, Odisha for personal hearing .The 2nd show cause notice was served on Shri Naik, Choukidar on dated the 14th May 2014. Shri Naik, Choukidar neither appeared before Director of Fisheries, Odisha nor submitted any written defence.

Now after careful and dispassionate examination of enquiry report and other connected documents as well as decision of Government thereof, the departmental proceeding drawn up against Shri Naib Naik, Choukidar vide this office Order No. 18366, dated the 23rd September 2006 is hereby finalized with following orders :—

Shri Naib Naik, Choukidar is no more in Government service with effect from the 5th June 1997 (i.e. from the date of his unauthorized absence from Government service more than five years).
