No. 33773—X-HE-SET-07/2016-HE.—Whereas, the draft of certain rules to amend the Odisha Education (Tribunal) Rules, 1977 was published as required by sub-section (1) of Section 27 of the Odisha Education Act, 1969 (Odisha Act 15 of 1969) in the Extraordinary Issue No. 901 of the *Odisha Gazette*, dated the 21st May 2016 under the notification of the Government of Odisha in the Higher Education Department No.11999—X-HE-SET-07/2016-HE., dated the 20th May 2016 inviting objections and suggestions from all persons likely to be affected thereby, till the expiry of a period of 30 (thirty) days from the date of publication of the said Notification in the *Odisha Gazette* ;

And, whereas, no objection and suggestion have been received in respect of the said draft amendment during the stipulated period of 30 days from the date of publication of the said notification in the *Odisha Gazette* ;

Now, therefore, in exercise of the powers conferred by Section 27 of the Odisha Education Act, 1969 (Odisha Act 15 of 1969), the State Government do hereby make the following rules to amend the Odisha Education (Tribunal) Rules, 1977, namely :—

1. (1) These rules may be called the Odisha Education (Tribunal) Amendment Rules, 2016.
(2) They shall come into force on the date of their publication in the *Odisha Gazette*.
2. In the Odisha Education (Tribunal) Rules, 1977, in Rule 4, in sub-clause (b) of Clause v, after the words “as there are respondents”, the words “and one more copy for service on Government Advocate of the Tribunal” shall be inserted.
