RESOLUTION

The 22nd December 2022

Subject—Payment of quantum of Additional Pension / Family Pension of the Basis Pension on completion of 80 years of age with similarly situated State Govt. Employees.

The Pension/ Family Pension/T.I. & Gratuity for the pensioners of the Urban Local Bodies of the State and Odisha State Municipal Council Union has beeb revised in H. & U.D. Department Resolution No. 1414/HUD., dated the 16th January 2020 as per revised Scale of Pay 2017 with effect from the 1st January 2016.

- 2. Representations have been received from different retired employees associations and retired employees from different ULBs for sanction of quantum of additional Pension/ Family Pension of the basic pension on completion of 80 years of age at per with similarly situated State Govt. Employees.
- 3. After careful consideration of the matter, the State Govt. in H. & U.D. Department have been pleased to accept the recommendation for additional quantum of pension on attaining the age 80 years and above.
 - (a) The quantum of additional pension/family pension would be made available to the old Pensioners/Family Pensioners from the date of publication in the Gazette are indicated as below:—

Age of pensioners/family pensioner	Additional quantum of pension
(1)	(2)
From 80 years to less than 85 years	20% of revised basic pension
From 85 years to less than 90 years	30% of revised basic pension
From 90 years to less than 95 years	40% of revised basic pension
From 95 years to less than 100 years	50% of revised basic pension
100 years or more	100% of revised basic pension

4. The Pension Sanctioning Authorities should ensure that the date of birth and the age of a Pensioner/Family Pensioner to facilitate the payment of additional pension by the pension disbursing authority as soon as it becomes due.

- 5. The amount of additional pension shall be shown distinctly while giving the pension/family pension. For example, in case where a pensioner is more than 80 years of age and his pension is Rs. 10,000 pm, the pension shall be shown as (i) Basic Pension=Rs. 10,000 and (ii) Additional Pension=Rs. 2,000 pm. The pension on his attaining the age of 85 years shall be shown as (i) Basic Pension=Rs. 10,000 and (ii) Additional Pension=Rs. 3,000 p.m.
- 6. All other provisions issued in Housing & Urban Development Department Resolution No. 1414/HUD, dated the 16th January 2020 are remain unchanged.

Ordered that the Resolution be published in an Extraordinary issue of the *Odisha Gazette* and forwarded to all Departments of Government/Heads of Department/RDCs/ Dist. Magistrates/all Municipal Corporations/all Municipalities/all Notified Area Councils/Odisha State Municipal Council Union.
