ORDER

The 7th January 2011

No. 524—In pursuance of Section 15-B(1) of the Shree Jagannath Temple Act and Rule 11(B) of the Rules made thereunder I, Shri Pradipta Kumar Mohapatra, I.A.S., Chief Administrator, Shree Jagannath Temple, Puri do hereby made the following amendments, in daily Niti of Serial No. 12 under the heading “ମଇଲମ ଓ ଭୋଗମଣ୍ଡପ” in Part-II of the Record of Rights prepared under the Shree Jagannath Temple, Puri (Administration) Act, 1952 —

#### AMENDMENTS

- (1) At page 22, under the same heading (12) “ମଇଲମ ଓ ଭୋଗମଣ୍ଡପ” in the 1st line let the words “ସକାଳ ଧୂପ ବସିଥିବା ବେଳେ” be deleted and in its place the words “ସକାଳ ଧୂପର ଯଥେଷ୍ଟ ପୂର୍ବରୁ” be inserted.
- (2) At page 22, under the same heading (12) “ମଇଲମ ଓ ଭୋଗମଣ୍ଡପ” in the 2nd line after the words “ସେମାନେ” and before the words “ଆସି” the words “ଯଥା ସମୟରେ” be inserted.
- (3) At page 22, under the same heading (12) “ମଇଲମ ଓ ଭୋଗମଣ୍ଡପ” in the 7th line after the words “ଭୋଗମଣ୍ଡପ ଦୁଆର ପ୍ରତିହାରୀ” and before the words “ଭିତର ଶୋଧ କରି” the following words be inserted :—  
“ସକାଳ ଧୂପ ପୂଜାପାଠ ପୂର୍ବରୁ ଉପସ୍ଥିତ ରହି ଭୋଗମଣ୍ଡପ”
- (4) At page 22, under the same heading (12) “ମଇଲମ ଓ ଭୋଗମଣ୍ଡପ” in the 9th line the words “ସୁଆର ଓ ମହାସୁଆରମାନେ ଭୋଗ ଆଣନ୍ତି” be deleted and the following words be substituted :—  
“ଦକ୍ଷିଣୀ ପ୍ରତିହାରୀ ସକାଳ ଧୂପ ଡାକିଗଲେ ସୁଆର ଓ ମହାସୁଆରମାନେ ନିର୍ଦ୍ଧାରିତ କୋଠଭୋଗ ବ୍ୟତୀତ ଅନ୍ୟ ସମସ୍ତ ଭୋଗ ଭୋଗମଣ୍ଡପକୁ ଆଣନ୍ତି” ।
- (5) At page 22, under the same heading (12) “ମଇଲମ ଓ ଭୋଗମଣ୍ଡପ” at the end of the 2nd paragraph the following words be inserted :—  
“ଜନସାଧାରଣଙ୍କ ସୁବିଧା ଦୃଷ୍ଟିରୁ ଆବଶ୍ୟକ ସ୍ଥଳେ ୨ୟ ଓ ୩ୟ ଭୋଗମଣ୍ଡପ ଧୂପ, ମଧ୍ୟାହ୍ନ ଧୂପ ଓ ସନ୍ଧ୍ୟା ଧୂପ ଭୋଗ ସହ ମଧ୍ୟ ଉଠା ଯାଇପାରିବ” ।
