NOTIFICATION

The 25th January, 2024

No.775—PDE-II-POLY-0005/2024/SDTE.— In exercise of the powers conferred by sub-section (1) of Section 53 read with clause (aa) of sub-section (2) of Section 53 of the Aadhaar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (18 of 2016), the Central Government, in consultation with Unique Identification Authority of India and as per the Rule 5 of Aadhaar Authentication for Good Governance (Social, Welfare, Innovation, Knowledge) Rules, 2020 have Authorized (eF. No.13(7)/2021-EG. II-Part (1), dated 26th December, 2023) the Skill Development & Technical Education Department, Government of Odisha ("herein referred as Implementing Agency") to use the Aadhaar Authentication Service facility on a voluntary basis, for biometric attendance of Government and private polytechnic students and Government ITI trainees of, using Yes/No Authentication facility

And, whereas, implementation of the Aadhaar-enabled Bio-Metric Attendance System for Government and Private Polytechnic students and Govt. ITI trainees of Odisha to improve the quality of education imparted to students and trainees through better attendance for their overall academic development by the implementing agency.

Now, therefore, in exercise of the power conferred by rule 5 of the said rules read with sub-clause (ii) of clause (b) of sub section (4) Section 4 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and services) Act, 2016 (18 of 2016), and as per Authorization of the Govt. of India under rule 4 of the said rules and as per the provision of the Aadhaar (Authentication) regulations, 2016

Aadhaar (Data Security) Regulations, 2016, Aadhaar (Sharing of information) Regulations, 2016 and other Laws (Amendment) Act, 2019 and other circulars and notifications issued from time to time, the Government of Odisha Skill Development & Technical Education Department hereby notify that the Aadhaar Authentication service shall be used, on voluntary basis, for the following purposes, namely.—

1. Aadhaar-enabled bio-metric attendance for Government and private polytechnic students and Govt. ITI trainees of Odisha to avoid proxy attendance.
2. To ensure better attendance of students and trainees in the institutes for overall academic development, resulting in an improvement in the quality of education.

This notification shall come into effect from the date of its publication in the Official Gazette.
