The 12th August 2016

No. 4560—II-P-21/2016-SDTE.—In exercise of power conferred under Section 3 (2) of the Odisha Professional Educational Institutions (Regulation of Admission and Fixation of Fee) Amendment Act, 2016, Government have been pleased to prescribe the following modalities for filling up of the vacant seats at Institution level with the qualified eligible candidates (as has been prescribed by the AICTE) after vacancy round of Diploma Counselling conducted by the Diploma Admission Committee, 2016:

- 1. The admission at Professional Educational Institution (hereinafter referred as diploma institutions) level shall be strictly done on merit basis in a fair and transparent manner. The candidates who have earlier registered their candidature in Diploma Counselling shall be preferred first followed by other candidates who have the requisite eligibility criteria as per the AICTE norms.
- 2. The following category of candidates are allowed for institute level admission against the vacant seats as declared by the Diploma Admission Committee/DTE&T, Odisha, Cuttack.:—
 - (i) The candidates who have not participated earlier rounds of Diploma Centralized Counselling.
 - (ii) The candidates who have participated in earlier rounds of Diploma Centralized Counselling but not got allotment of seats.
 - (iii) Candidates who have been allotted seats in earlier of two rounds of Counselling but not reported at the allotted institute. In this regard, the concerned institute should submit non-reported candidates list to the Diploma Admission Committee, 2016 on or before the 14th August 2016 which will be duly verified by the Diploma Admission Committee, 2016.
 - (iv) The candidates who have withdrawn after temporary allotment.

- 3. The Institute shall conduct counselling of candidates who have the requisite eligibility criteria as per the AICTE norms and shall furnish the documents of eligible reported candidates to Diploma Admission Committee, 2016 in support of the admission in respective institute. Candidates found ineligible (as per criteria prescribed by the AICTE and indicated in Councelling Brochure of Diploma Admission, 2016) during documents verfication will be debarred from admission.
- 4. List of students, admitted by the institute should be submitted to Diploma Admission Committee, 2016 by mail id:dacdtetodisha@gmail.com before the15th August 2016 positively duly signed by the concerned Principal on each page of the list and in no case hard copy of the list shall be entertained. Any list of the students beyond the said dateline (15-08-2016) prescribed by the Government shall not be considered at any point of time.
- The institutions are required to submit the documents of the admitted candidates for verification by the Diploma Admission Committee, 2016 and their decision in the matter is final and binding.
- 6. The students eligible for admission under said vacant seats will be issued with Registration Number by the SCTE &VT after due verification by Diploma Admission Committee following the Rules, Regulations of the Council concerned.
- **7.** The guidelines/provisions/eligibility criteria regarding admission prescribed by the AICTE and in the Brochure for Diploma Admission, 2016 shall be followed meticulously.
- **8.** The Principals of the Institutions who are making admission at Institution level are to verify the documents duly and confirm that the admissions are as per the norms/guidelines/rules prescribed by the Government and they shall submit an affidavit in this regard while submitting documents to the Diploma Admission Committee, 2016 for verification.

For any clarification, if so, necessary the decision of the Government in Skill Development & Technical Education Department is final and binding.
