NOTIFICATION

**S.R.O. No. 76/2016**—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village Jhadarandiba and Tuburuba under Ramgiri-Udayagiri Tahasil of the District of Gajapati mutated and transferred in favour of Forest Department for compensatory afforestation purposes against the proposed diversion of forest land for construction of Chheligada Medium Irrigation project in Gajapati district vide Stage-I Forest Clearance Order F.No. 8-47/2002-FC., dated the 16th/17th October 2002 of Government of India, Ministry of Environment and Forests under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 289.73 Acres or 117.535 Ha. shall be Protected Forests with effect from the date of issue of the notification and shall be known as "Jhadarandiba and Tuburuba Protected Forest":—
