RESOLUTION

The 5th April, 2021

Guidelines for Integrated Infrastructure Complex

1. Introduction:

- a. Maintenance and Welfare of Parents and Senior Citizens Act, 2007 was enacted to ensure need based maintenance for parents and senior citizens and their welfare. The Act envisages for establishment of old age homes for indigent senior citizens as well as creation of adequate medical facilities and security for senior citizens.
- b. Rights of Persons with Disabilities Act, 2016 raised disability categories from seven to twenty-one. The Act provides for education, employment, creation of barrier free environment, social security etc to persons with disability.

2. Background:

- a. Legislative and policy mandates contained in Maintenance and Welfare of Parents and Senior Citizens Act, 2007; Rights of Persons with Disabilities Act, 2016 and Mental Health Care Act 2017 as well as relevant policies casted upon the State to develop mechanisms for ensuring empowerment of beneficiaries under social security net through sustainable support systems.
- b. Action plan for implementation of 5Ts included developing Integrated Infrastructure Complexes as National Centres of Excellence with facilities of Old Age Home, Skill Development Centre, Special School, Mentally ill Home and Rehabilitation Centre. This Infrastructure will aim at holistic geriatric care and improving the lives of Persons with autism, cerebral palsy, mental illness, multiple disabilities, other PwDs. These categories of Persons usually eke out a miserable existence and are subject to exploitation, abuse and

neglect causing depression, anguish and resentment. To provide such individuals social, economic and emotional support & develop an environment congenial to their full & effective particular in social life.

- c. Hon'ble Supreme Court in case No. WP(c) No. 193 of 2016 in Dr. Ashwini Kumar Vrs. Union of India and others issued directives for providing Pension, Shelter and Geriatric and medical care and in case No. WP(c) No. 412 of 2016 in Gaurav Kumar Bansal Vrs. Union of India & others issued directives for providing shelter home for the mentally ill.
- d. There has been a steady rise in the population of older persons in Odisha. Census of India 2011 enumerated Senior Citizen population of Odisha at 39,84,448 accounting for 9.49% of total population of the State which is higher than national average (8.58%). The number of elder persons has increased from 22.81 lakhs in 1991 to 30.39 lakhs in 2001 and 39.8 lakhs in 2011. The present proportion of 9.5 per cent of senior citizens is estimated to reach 13.8 percent, numbering 62.69 lakhs in 2026. Estimated population of Senior Citizens comes to 44.49 lakhs in 2019.
- e. Census of India 2011 estimated the PwD Population of Odisha at 12, 44,402 accounting for 2.96% of the total population of the State which is 0.75% higher than the national average (2.21%) which envisages the State has a higher prevalence rate of disability. The number of PwD population in Odisha increased from 10.21 lakhs in 2001 to 12.44 lakhs in 2011. Estimated population of PwDs comes to 14.62 lakhs in 2019. Further, Census data has covered 8 categories of PwDs whereas category of PwDs is raised to 21 categories and as per RPwD Act, 2016. Different estimates show current rate of prevalence of disability will be between 10-15%.
- f. Social Security of Senior Citizens, PwDs, Beggars and Victims of substance abuse requiring comprehensive rehabilitation services by technical manpower under one roof on regular basis. The need for creating such composite centre capable of providing all range of quality services is being urged time and again to improve the conditions of PwDs, Senior citizen and other beneficiaries. These facilities involve creation of infrastructure including technical equipment, manpower, and an effective monitoring mechanism involving a higher investment.

3. Programmes: IICs are conceived at the district level which will house the following amenities in phases:

- a. Home for Senior Citizens
- b. Destitute Home
- c. School for Visually Impaired
- d. School for Hearing Impaired
- e. School for Intellectually Disabled
- f. Early Intervention Centre
- g. Physiotherapy centre
- h. Mobile medical unit
- i. DDRC
- j. Advanced Rehabilitation Centre (ARC)

4. Budget: The Integrated Infrastructure Complex will function with inmate capacity of about 400 senior citizens/ destitute/ children with disability initially. The numbers will be enhanced depending on local requirement. Operational cost will be provide to the management as follows:

5. Selection of NGOs/ Management:

- a. **Option 1:** Existing school management/ NGO is allowed to use the infrastructure at the IIC for running the school. The NGO will relocate the special school to the IIC. The premises will not be handed over to the management and will continue to remain under the administrative control of DSSO and maintenance will be with R&B Department. Management will run the school as per the guidelines of SSEPD Department. District administration will identify the NGO following due process.

- b. **Option 2:** Corporate houses become mentor/ sponsor for a special school. Applications in this regard will be submitted to the Collector and the Collector will recommend such cases to SSEPD Department after due scrutiny by the District Level Committee. In such cases the sponsor/corporate house may identify the NGO/Organization to run the institution and recommend to the Collector. Selection of NGO will be finalized jointly after due consultation between the Collector and the Sponsor. Students from existing special schools will be relocated to the school. The corporate house can fund partial/ additional capital expenditure. Corporate house will meet the entire running cost. Management will get full autonomy for recruitment/ disengagement of staff. Guidelines of SSEPD Department will be amended for these schools for providing additional autonomy. Sponsor will provide handholding for a finishing school and employment/ further studies thereafter. They will also support self employment options of the students. Government Approval will be necessary in this regard.

6. Selection of NGO in case of Option 1 (in Para. 5):

- a. **Application:** Collector of the district will invite application from interested NGOs (NGOs can have their registered office in any district inside the state of Odisha) for running old age homes, home for the destitute, special school for VI, special school for HI and school for those with intellectual disability. An NGO can be also selected for running multiple institutions. Collector will also invite application for running physiotherapy centre and mobile medical unit within the IIC. NGOs will need to fill up the form as placed in **Annexure Z** while applying. Following committee will be formed in the District level for selection of NGOs.

- 1) Collector - Chairman
- 2) ADM -Member
- 3) CDMO-member
- 4) DSSO-Member Convener
- 5) DEO-Member
- 6) Any other member(s) to be co-opted by the Collector

- b. **Criteria for Selection of NGOs at District level:** NGOs will be chosen purely based on technical evaluation. 50 marks will be given for the parameters mentioned in the application form (**part B in Annexure Z**).

Another 50 marks will be for the technical presentation. Decision of the Committee will be final in this regard.

7. Security at the main gate and the common areas will be provided by the department. However, concerned management/ NGO will be responsible for providing security inside the premises of the individual units. Security will be ensured round the clock.
8. There will be a consultant, assisted by support staff to coordinate among different NGOs managing individual units. In case of any dispute between any two or more NGOs, the decision of the Consultant will be binding.
9. A centralized kitchen will be made operational in each IIC. Its operation will be outsourced to a competent organization. A committee will be constituted under the

chair of the Consultant, with participation of managing NGOs for overall supervision the centralized kitchen.

- 10. Release of Funds:** Funds will be released in two instalments to the management (NGO). The first instalment will be released to the management during the first week of April. On submission of the inspection report and UC for the previous year, the second instalment will be released during September.
- 11.** Separate electric meter will be installed for the common areas. Electricity dues for the common areas will be paid separately by the department. Electricity dues for the individual units will be paid by the management and the cost will be built into the overall management cost.
- 12. Outcomes:** Increase in the numbers and proportions of older persons and PwDs can be expected to have far reaching economic, social and political implications. In Odisha the number of older persons and PwDs are increasing faster than the number of people in the traditional working ages, leading to a larger task ahead. However, the IIC complexes will have the following outcomes:
- a. All 30 IIC complexes will provide shelter to 12000 persons including senior citizens and children with disabilities initially.
 - b. The IIC complexes will have provision for medical care, therapeutic services, counselling, assistive devices and physical rehabilitation services for all the inmates.
 - c. Support will be provided to children with disabilities for special or inclusive education, vocational training and other rehabilitation guidance.
 - d. PwDs and senior citizens will avail opportunities for yoga and meditation, sports, spiritual, cultural and other recreational facilities.
