NOTIFICATION

S.R.O. No. 137/2023—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village - **Phuljhar** under Banspal Tahasil in the District of Keonjhar mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation thereon against proposed diversion for non-forestry use of 63.30 ha Sabik Kisam Forest land in addition to 371.192 ha of forest land already diverted forest land located within the Mining Lease hold area of 767.284 ha in favour of M/s JSW Steel Ltd. for Nuagaon Iron Ore Mines in Barbil Tahasil of District Keonjhar (Odisha) therein vide 'in-principle' approval of Government of India, MoEF&CC (FC Division), New Delhi communicated in letter No.8-17/2001-FC, dt.14.03.2022 under section-2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 63.30 Ha(156.416 Ac) shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "**PhuljharProtected Forest**".
