S.R.O No.32/2020– In exercise of the powers conferred by sub-clause (d) of clause (8) of Section 2 of the Official Secrets Act, 1923 (19 of 1923) read with notification of the Government of India in the Ministry of Home Affairs No. F-21/20/62 Poll (I) dated the 4th May, 1963, bearing No. S.O. 1284, published in the Gazette of India, dated the 11th May, 1963, Part II, the State Government do hereby declare the Indian Oil Corporation Limited, Balasore Depot, Somnathpur Industrial Estate, Somnathpur situated at village Palasandha under Remuna Tahasil, P.S-Remuna in the District of Balasore having an area of Ac. 41.34 Dec. as specified in the Schedule below to be prohibited place for the purpose of the said Act,-
