NOTIFICATION

S.R.O. No. 254/2020—In exercise of the powers conferred under Section 33 of the Odisha Forest Act 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village Muskuti under Lanjigarh Tahasil in the district of Kalahandi mutated and transferred in favour of Forest & Environment Department for the purpose of raising compensatory afforestation thereon against the proposed diversion of 26.244 Ha. (64.85 acres) of Revenue forest land located inside Lanjigarh Aluminium Refinery Complex in Kalahandi District, Odisha for maintaining it as Green belt by M/s Vedanta Ltd. vide in-principle approval Order No.5-ORC264/2015-BHU dated the 14th October 2015 of Government of India, Ministry of Environment, Forest & Climate Change, Eastern Regional Office, Bhubaneswar under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 30.6387 Ha. (75.710 acres), shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Muskuti Protected Forest”.
