NOTIFICATION

No. 523—Ele.(G.P.)-01/2017-SEC.—Whereas, State Election Commission, Odisha has issued Notification to elect Panchayat Samiti Members of the State vide Notification No. 5164, dated the 27th December 2016 excluding Panchayat Samiti Members of Dasarathpur Panchayat Samiti of Jajpur District as per the interim orders of the Hon'ble High Court of Orissa in W. P. (C) No. 15614 of 2016 and 16151 of 2016 ;

Whereas, in the meantime the Hon'ble High Court of Orissa in Order Nos. 7 and 14 all, dated the 9th January 2017 have vacated the interim stay order.

Now, the State Election Commission, Odisha, therefore, in exercise of its powers conferred under Article 243-K of the Constitution of India and other enabling powers in that behalf hereby appoints the following date and time with respect to the elections of Panchayat Samiti Members of Dasarathpur Panchayat Samiti of Jajpur District :
