RESOLUTION

The 26th November 2016

SUBJECT—Framing of Odisha Healthcare Investment Promotion Policy, 2016

1. Preamble :

Government of Odisha is committed to create an investment environment where public and private sector players can play a pivotal role in the growth of the healthcare sector in the identified priority districts of the State.

This Policy shall act as a catalyst for providing quality healthcare services and attracting higher investment in the healthcare sector in the priority districts of the State.

2. Vision :

To realize the State's commitment to :

- (a) Provided quality healthcare services to its citizens in the priority districts/subdivisions
- (b) Promote private sector investment in the healthcare sector through strategic partnerships, investment and policy interventions.

3. Objectives :

- (a) To ensure delivery of quality healthcare services in the priority districts of the State at reasonable costs.
- (b) Ensure improved acces and affordability of secondary and tertiary healthcare services in the State.
- (c) Provide impetus to growth of private sector healthcare investments, to ensure alignment with public health goals and enable making healthcare systems more effective, efficient, rational, safe, affordable and ethical.

- (d) Promote establishment of healthcare institutions for best-in-class infrastructure and technology in healthcare delivery in the priority districts.

4. Policy Period :

The Policy will remain in operation for a period of five (5) years from the date of its notification until substituted by another Policy.

5. Industry Status :

Healthcare sector investments in priority districts shall be accorded all the incentives present in the Industrial Policy Resolution, 2015 and shall be treated at par with the priority sector investments.

6. Scope :

The Policy would provide incentives and exemptions in conjunction with any other applicable existing policy of the State and Government of India.

An investor may choose a particular provision from either this policy or any other policy, but not both.

7. Priority Districts :

The primary purpose of this policy is to ensure quality healthcare services in identified priority districts of the State. The list of these priority districts is as follows :

- 1. Balangir
- 2. Boudh
- 3. Gajapati
- 4. Kalahandi
- 5. Kandhamal
- 6. Koraput
- 7. Malkangiri
- 8. Nawarangapur
- 9. Nuapada
- 10. Rayagada
- 11. Sonepur

8. Eligible Hospital Projects :

A hospital shall be an institution for healthcare services (including modern allopathy and mental health) providing specialized treatment including but not limited to curative and rehabilitative care services and including promotional, preventive healthcare services. The hospital projects shall be grade as follows :

Grade '1': Hospitals under 100 beds

Grade '2': Hospitals under 101–200 beds

Grade '3': Hospitals 201-300 beds

Grade '4': Hospitals 301-400 beds

Grade '5' : Hospitals 401–500 beds

Grade '6' and above : For every additional 100 beds above 500, the hospital will qualify for the next higher Grade.

The minimum requisite number of doctors and support staff for each grade will be as per the Indian Public Health Standards (IPHS) guidelines.

All incentives, support and assistance under the Policy shall be applicable for eligible hospital projects developed under Grade '1' and above, with minimum of 50 beds in the identified Priority Districts.

Enterprises intending to establish healthcare facilities as part of Corporate Social Responsibility shall also be encouraged for the development of hospital projects in priority districts. Dovetailing of the CSR funds with the various schemes of the Government for setting up such hospital projects shall also be explored.

9. Incentives :

9.1. Capital Subsidy :

Capital subsidy shall be provided on capital investments made in the project. The subsidy will not be provided on capital investment made towards cost of land, working capital and operative expenses. The subsidy shall be limited to 30% of the capital investment subject to ceiling of Rs. 10 Crore for Grade '1' and additional ceiling of Rs. 5 crore for each higher grade hospital as applicable under provisions of this Policy.

9.2. Incentives an Expansion :

An existing hospital in the priority district, which upgrades into a multispecialty hospital or a super specialty hospital shall be eligible to avail incentives on additional capital investment for the expansion on the same line as aviailable for setting up new hospitals in this policy, provided the new capacity/expansion planned has at least 50% additional beds of the existing capacity and the existing capacity is of at least 100 beds.

9.3. Allotment of Government Land :

Government will provide priority in allocation of land for the new hospital projects in priority districts subject to availability at concessional land rates mentioned in the Industrial Policy Resolution 2005 and as revised from time to time. Applicable norms of Government and Medical Council of India shall be applicable for assessment of land requirement for setting up a new project.

10. Governance :

The policy shall enable proper implemementation and smooth functioning of the provisions to facilicate healthcare investments in the priority districts of the State.

All projects to be covered under this Policy shall go through the State Level Single Window Clearance Authority (SLSWCA) through IPICOL for clearance as per the prevailing practice for large industries in the State. Principal Secretary, Health & Family Welafre Department shall be part of the SLSWCA while considering the healthcare sector projects.

11. General Terms and Condition :

- (a) For the purpose of this policy all terms, definitions and interpretations shall be as per the policies of the State Government for promotion and development of healthcare activities.
- (b) Doubts relating to interpretation of any term and/or dispute relating to the operation of any provision under this policy shall have to be referred to the Health & Family Welfare Department, Government of Odisha for clarification/resolution and the decision of Government in this regard shall be final and binding on all concerned.
- (c) No right or claim for any incentive under this policy shall be deemed to be conferred merely on the ground of provision in this policy. Implementation of various provisions covering the incentives, concessions, etc. will be subject to the issue of detailed guidelines/statutory notifications, wherever necessary in respect of each item by the concerned Administrative Department.
- (d) The State Government may at any time amend any provision of this Policy.
