SUBJECT:—Restructuring of Odisha Statistics & Economics Service Cadre

The need for reliable statistics is well felt in every sphere which helps to breakdown the complexity of facts to more meaningful information by analyzing, comparing and evaluating. The Directorate of Economics and Statistics (DES), Odisha is the apex statistical institution of the state and plays a vital role in the State statistical system and has been greatly expanded.

Keeping in view the changing needs, the proposal for restructuring of Odisha Statistics & Economics Service Cadre (OS&ES) was under active consideration for some time past. After careful consideration, the State Government have been pleased to restructure the Odisha Statistics & Economics Service Cadre (OS&ES) under administrative control of P.&C. Department in following manner:—

- 2. (i) 3(three) Nos. of posts of Additional Directors are created by upgrading 3 nos. of existing posts of Joint Directors Level-I.
- (ii) The existing posts of Joint Director Level-I and Joint Director Level-2 are merged to form the post of Joint Director in the Scale of Pay of PB-3-Rs 15,600-39,100 + GP RS 7,600, i.e Level-14 in the ORSP-2017.
- (iii) 3(three) Nos. of posts of Joint Directors are created by upgrading 3 Nos. of existing posts of Deputy Director.
- (iv) 9(nine) Nos. of post of Deputy Directors are created by upgrading 9 nos. of existing posts of Assistant Directors.
- 3. (i) The residency period for promotion to the post of Additional Director from the post of Joint Director is 1(one) year as Joint Director or 12(twelve) years as Assistant Director, Deputy Director & Joint Director taken together.
- (ii) The residency period for promotion to the post of Joint Director from the post of Deputy Director is 4(four) years as Deputy Director or 10(ten) years as Assistant Director & Deputy Director taken together.
- (iii) The residency period for promotion to the post of Deputy Director from the post of Assistant Director is 6(six) years.
- 4. The post of Assistant Director under OS&ES Cadre shall continue to be a part of OSE&S Cadre as before.
 - 5. This has been concurred in by Finance Department in OSWAS file No. PC-ES-0002- 2015
- 6. This shall come into force with immediate effect. Necessary Amendment in Odisha Statistics and Economics Services Rules, 1979 as amended from time to time shall be made shortly following due procedures.
