2. They are directed to join in the post of Assistant Director in the office of the concerned DPMUs as mentioned above within 30(thirty) days from the date of receipt of the posting order failing which the order of appointment will be cancelled.

3. His/her date of Joining in service shall be counted from the actual date of joining in their respective place of posting.

4. The appointment is also subject to verification of their character and medical fitness and furnishing an undertaking to the effect that he/she has no more than one spouse living in case he/she is married unless he/she produce original certificates/documents that the State Government has exempted his/her case for operation of this limitation for any good and sufficient reasons. In case an adverse report is received, the services of the candidates concerned would be terminated forthwith.
