S.R.O.No. 305/2021—In exercise of the powers conferred by sub-clause (d) of clause (8) of Section 2 of the Official Secrets Act., 1923 (19 of 1923), read with the notification of the Government of India in the Ministry of Home Affairs No. F-21/20/62 Poll (I) dated the 4th May, 1963, bearing No. S.O. 1284, published in the Gazette of India, dated the 11th May, 1963, Part II, the State Government do hereby declare the Repeater *cum* Cathodic Protection (RCP) and Sectionalizing Motor operated Valve (MOV) stations of Paradip-Raipur-Ranchi Pipeline of Indian Oil Corporation Limited (IOCL) situated at villages Attabira, Kalapani, Rungunia, Chakarkend and Pandakipali in the District of Bargarh having an area of Ac 1.73 Decs as specified in the Schedule below to be prohibited place for the purpose of the said Act.
