- (II) The functions of the State Board of Madrasa would be as follows:
 - i. To conduct Madrasa Examination in the State on the courses already prescribed by the Odisha State Board of Madrasa Education.
 - ii. To prescribe courses of studies and recommend books for different stage of Madrasa Education.
 - iii. To conduct Examinations based such rules as may be prescribed by the Board
 - iv. To admit candidates to the Examinations according to the rules to be framed by the Board.
 - v. To publish the rules of Examinations
 - vi. To accord recognition to Madrasa on the basis of the rules to be framed
 - vii. To take up such work as may be entrusted to the Board by the Government in the interest of Madrasa Education.
- (III) This supersedes earlier Notification issued to the above extent.
