S.R.O. No. 258/2020—In exercise of the powers conferred under Section 33 of the Odisha Forest Act 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in village Kantakhola under Kamakhyanagar Tahasil in the district of Dhenkanal mutated and transferred in favour of Forest & Environment Department for the purpose of raising compensatory afforestation thereon against the proposed diversion of 38.098 Ha. of Revenue forest land for construction of 3 X 800 MW Thermal Power Plant under Kamakhyanagar Tahasil of Dhenkanal District by Odisha Thermal Power Corporation Ltd. vide in-principle approval Order No.5-ORC383/2019-BHU, dated the 7th June 2019 of Government of India, Ministry of Environment, Forests & Climate Change, Eastern Regional Office, Bhubaneswar under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 11.7359 Ha. (29.000 acres), shall be Protected Forests with effect from the date of issue of the Notification and shall be known as "Kantakhola (A) Protected Forest".
