**S. R. O. No. 112**/2017—Whereas, State Election Commission, Odisha has issued Notification to elect Panchayat Samiti Members of the State vide Notification No. 5164, dated the 27th December 2016 excluding Panchayat Samiti Members of Parjang Panchayat Samiti of Dhenkanal District, Kolabira Panchayat Samiti of Jharsuguda District, Bhawanipatna Panchayat Samiti of Kalahandi District and Rengali Panchayat Samiti of Sambalpur District as per the interim orders of the Hon'ble High Court of Orissa in W. P. (C) No. 16152, 16465, 17247, 20601 and 17362 of 2016 respectively;

Whereas, in the mean time the Hon'ble High Court of Orissa in Order No. 10 and 12 all, dated the 25th January 2017 have vacated the interim stay order;
