No. 3733—POLLEX-1-34/2015—In suppression of Home Department Notification No. 14753, dated the 4th April 2012, the Governor of Odisha is pleased to reconstitute the Odisha Rajya Sainik Board with effect from the date issue of Notification for a period of three years.

The main objects and constitution of the Board will be as under—

**Main objects of the Board :**

1. Co-ordinating the works of Zilla Sainik Boards in the State
2. Promoting measures for the welfare and resettlement of ex servicemen and families of serving/deceased personals of the Armed Forces.
3. Disseminating information to the general public regarding Armed Forces in the country and taking measures to raise an intelligent interest in Armed Forces amongst the members of the general public.
4. Administering the Zilla Sainik Boards in the State in accordance with the rules and instructions prescribed by the Central and State Governments.
