ORDER

The 8th December 2016

No. 4890—Ele. (GP)-05/2016-SEC.—Whereas, preparation of electoral roll for R.R.Pur and Kotsahi Grama Panchayats of Jaleswar Block in Balasore District ordered vide Order No. 4/40/SEC., dated the 30th November 2016 could not be taken up due to non-finalisation of case pertaining to these Grama Panchayats ;

Whereas, it is reported by the District Panchayat Office, Balasore vide Letter No. 2491, dated the 6th December 2016 that exercise of Delimitation of Wards, Reservation of Seats of these two Grama Panchayats has been taken up after finalization of case on reorganisation of Grama Panchayat and it is necessary to prepare Wardwise electoral roll of these Grama Panchayats mentioned above.

Now, therefore, the State Election Commission in exercise of powers vested by virtue of Article 243-K of the Constitution of India read with relevant provisions of Odisha Grama Panchayat Act, 1964, Odisha Panchayat Samiti Act, 1959 and Odisha Zilla Parishad Act, 1991 and Rules framed thereunder directs that Wardwise electoral roll of concerned Grama Panchayats shall be prepared in Form No.1 as per the programme in Schedule appointed herewith.

Other procedure for preparation of electoral roll communicated earlier shall remain unchanged .
