NOTICE

1. Partnership Firm namely-M/s. Hotel Swagath, Rayagada bearing Firm Regn. No. 422/1980, dated the 23rd September 1980 at New Colony, P.O./P.S./Tahasil/Dist. Rayagada (Odisha) the partnership deed of which was executed on the 1st June, 1980 was constituted between (1) Vattam Appalaswami, S/o Late V. Parayya (2) Vattam Rama Rao, S/o V. Appalaswami and (3) Vattam Kesava Rao, S/o V. Appalaswami, all of Rayagada as Partners.

2. One of the partners— Vattam Appalaswami expired on the 20th December 1982 and the said firm has been constituted with the other two surviving and existing partners nemely-(1) Vattam Rama Rao and (2) Vattam Kesava Rao vide Partnership Deed, dated the 31st December 1982 which was duly published vide notice dated the 16th July 1983 in the "Samaj" Odiya Daily Newspaper, dated the 28th July 1983 and the Odisha Gazette, dated the 12th August 1983 in page No. 782.

3. Again, in pursuance of Income Tax Amendment under Section 40(b), the Partnership Firm was subjected to constitution with effect from the 1st April 1992 among the existing and continuing partners which is constituted.

4. At this stage, one of the partners-Vattam Kevasa Rao resigned from Partnership Firm with effect from the 1st April 2010 giving 3 months' notice on the 1st January 2010 for which an Affidavit was sworn on dated the 19th March 2012 bearing SI. No. 2381, before the Notary Public Smt. Jyotsnarani which was published in 'Samayo' Odia Daily Newspaper on the 18th March 2012 and also in Indian Express, English Daily Newspaper on the 25th March 2012. That the said notice so published reads as follows that :—

"This is for information of General Public and all concerned that consequent upon swearing an affidavit before Smt. Jyotsanarani, Notary, Rayagada on the 20th March 2012, I Vattam Kesava Rao, S/o Late V. Appalaswami, Kapu Street, Rayagada declare my resignation from Partnership Firm of Hotel Swagath, New Colony, Rayagada with effect from the 1st April 2010 by giving 3 months' notice."

So the Firm has again been reconstituted with V. Srinivas, S/o V. Rama Rao as a New Partner (incoming partner) with effect from the 1st April 2010 and the same is in force till now with the following profit share ratio :

(i) Vattam Rama Rao-existing partner with 60% share (Continuing Managing Partner).

- (ii) Vattam Sreenivas—in-coming partner with 40% share
- (iii) Vattam Kesava Rao-Retd. Outgoing partner with effect from the 1st April 2010
