## The 7th August 2023

**S.R.O. No.540**/2023.—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village Tiriba under Telkoi (now Banspat) Tahasil in the District of Keonjhar mutated and transferred in favour of Forest, Environment & Climate Change Department for the purpose of raising Compensatory Afforestation thereon against the approved diversion of 145.329 ha. of forest land in Village-Bamebari, Jaribahal etc. in Keonjhar Forest Division for Iron and Manganese Ore mining in favour of M/s TISCO Limited in Odisha vide Order No. F. No.8-72/220-FC. dated the 25th January 2007 of Government of India, Ministry of Environment & Forests (FC Division), New Delhi under Section, 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 40.660 ha (100.473 acres), shall be 'Protected Forests' with effect from the date of issue of the Notification and shall be known as "Tiriba Protected Forest".
