- * The Member-Convenor, while intimating the date, time and venue of the meeting, shall supply a copy of the draft scheme for R and R to all the members.
 - * The quorum of the meeting shall be not less than two thirds of all members.
 - * The meeting shall be held at least once in every three months.
 - * The first meeting shall be convened before award is made under Section 31 and successive meetings will review the payment entitlements and work out the displacement work plan on agreed terms.
 - * After completion of resettlement process, the R and R Committee shall suggest the name of an organisation to undertake an independent social audit at the cost payable by the District Collector.
