**S.R.O. No. 265/2023**—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village Panchada under Laxmipur Tahasil in the district of Koraput mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation thereon against the proposed diversion of 4.032 ha of Revenue forest land in favour of Kalinga Institute of Social Science (KISS), Bhubaneswar for development of education facilities for the Tribal students in the district of Khurda under Chandaka Wildlife Division vide 'in-principle' approval of Government of India, MoEF&CC, IRO, Bhubaneswar communicated in Letter No. 5-ORB425/2020-BHU, dated the 7th September 2021 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 4.172 ha (10.310 Ac) shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "Panchada Protected forest":—
