No. 21718—DAFE-AFE-FE-0130/2022/Ag&.FE.—The following Agriculture District Officers (ADOs) /Deputy Directors of Agriculture (DDAs) are promoted to the rank of Chief District Agriculture Officer (CDAO) / Joint Director of Agriculture (JDA), Level-II on *ad hoc* basis in the Pay Scale of Level-13 of Pay Matrix under ORSP Rules, 2017 for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. This *ad hoc* promotion Is subject to concurrence of the OPSC on their earlier *ad hoc* promotion to the rank of ADO/DDA.
