The nomination of contesting candidates except the deceased whose names have been published under Rule 32(5) on the previous occasion i. e. on the 16th January 2016 during last by election shall remain valid. They shall not file nominations again and they shall be intimated about the election schedule.

3. Withdrawal of candidature is only permissible for those candidates who are going to file nomination during this period.

4. Allotment of symbol shall be done afresh in odia alphabetical order.
