NOTIFICATION

S. R. O. No. 520/2016—Whereas, the draft notification for the purpose of inclusion of additional 22 (Twenty-two) Revenue Villages in Sambalpur Development Authority Area declared as such in the notification of the Government of Odisha in the Housing & Urban Development Department No. 22060, dated the 3rd June 1989 and No. 20345, dated the 15th July 2011 was published as required by Rule 3(1) of the Odisha Development Authorities Rules, 1983 in the Extraordinary issue of the *Odisha Gazette* No. 776, dated the 30th April 2016 under the notification of the Government in the Housing & Urban Development Department No. 9179, dated the 18th April 2016 ;

And whereas, no objection and suggestion was received in respect of the said draft before the expiry on the date specified by the State Government in the said notification.

Now, therefore, in the exercise of the powers conferred by sub-section (2) of Section 3 of the Odisha Development Authorities Act, 1982 and in partial modification to the Government of Odisha in the Housing & Urban Development Department Notification No. 22060, dated the 3rd June 1989 and No. 20345, dated the 15th July 2011, the State Government do hereby declare that the existing Sambalpur Development Area shall include the additional areas of the revenue villages as mentioned in Column (2) of Schedule - I below and accordingly the boundaries of Sambalpur Development Area shall be described in Schedule - II below :
