Where as, Govt. in R&DM Department has issued Notification U/s-4(1) of the RFCTLAR&R Act, 2013 intending to acquire Ac.1.144dec of land in village Unit-7 Sitaleswar for "Improvement to four lane standard of Jajpur Town Road from Women's College square to Ballabhighat via Gariapur Chhak from 0/000Km to 1/875Km" and allowed SIA study vide No.37054/dtd.18.12.2020.

Whereas, Govt. in R&DM Department has issued declaration U/s-8(2) of the RFCTLAR & R Act, 2013 vide No.26858 dtd.10.08.2022 for acquisition of Ac.1.144dec after examining the report of the Collector, Jajpur and the report of the Export Group.

Whereas, consequent upon receipt of the report of Superintending Engineer, panikoili (R&B) Division, Panikoili vide letter No.1301(WE)/dtd.07.02.2023 regarding acquisition of Ac.1.01078dec out of the above Ac.1.144dec through Direct purchase, Notification U/s-11(1) of the RFCTLAR & R Act, 2013 was issued by the Collector, Jajpur as the appropriate Govt. vide No.1564/dtd.20.02.23 for acquisition of Ac.0.12622dec leaving an area of Ac.0.007dec through over side.

As such, the Notification issued U/s-11(1) may be read as per the following schedule instead of the schedule given in the above Notification.
