Attention Please :—

- A. Printed nomination papers are available at Odisha State Bar Council Office and cost of one nomination paper is Rs. 100 only.
- B. Out of total number of 25 seats 13 seats shall be filled up by persons who have for atleast 10 years been advocate on a State Roll as per proviso to Sec.-3(2)(b) of the Advocates' Act 1961.
- C. Nomination Fees : Rs. 30,000 which is non-refundable.
- D. Programme No. 1 to 3 above before Secretary/Returning Officer, Odisha State Bar Council at Cuttack and Programme No. 4 in the Office of the Odisha State Bar Council at Cuttack.
- E. Candidate along with Proposer and Secunder shall remain present physically at the time of filing of nomination with their I-Card preferably issued by Bar Council or their respective Bar Association.

N.B. : The office-bearers of any Bar Association would not be eligible to contest the elections of State Bar Councils. The word office-bearer shall mean and include the President, Vice-President, General Secretary or Secretary or Secretary General of the Bar Associations, but it will not include Joint Secretary, Assistant Secretary or any other office-bearer, Provided that this restriction will not be applicable to the office-bearers of Supreme Court Bar Association.
