2. The appointment is purely temporary and terminable at any time without any prior notice and without assigning any reasons thereof.

3. They will remain in probation for a period of two years with the condition that they should complete the probation to the satisfaction of the authority failing which their services will be terminated at any time in terms of provision of Clause (h) of Rule 13 of OCS (CCA) Rules, 1962.

4. The appointees should join in their place of posting within one month from the date of this notification failing which their appointment shall be automatically cancelled.

5. The appointment is subject to their medical fitness to be determined by the Medical Officer not below the rank of CDMO and satisfactory verification of his character and antecedents by the appropriate authority. In case, any adverse report is received, the services of the appointee concerned would be terminated forthwith in accordance with the provisions laid down in sub-clause (ii) of Clause (h) of explanation under Rule 13 of OCS (CCA) Rules, 1962.

6. No TA/DA is allowed to join in the post.
