No. 2538—LVIII-05/2016-Ex.—In exercise of the powers conferred by sub-section (7) of Section 90 of the Bihar & Odisha Excise Act, 1915 (Bihar & Odisha Act 2 of 1915), read with (A) (4) and 41 (c) of Board's Excise Rules, 1965 as amended in Board's Notification No. 4797-Ex., dated the 10th June 1966, the Board of Revenue hereby direct that the fee prescribed for issue of permit for approval of labels and brand of foreign liquor and renewal of the permits in item (A) (i) (ii) (B) (C) and (D) of the Board's Notification No. 4830, dated the 10th June 1996 shall be amended as follows:

AMENDMENT

In Rule II (A) (C), the fee prescribed in Board Notification which was last amended in Board's Notification No. 2836-Ex., dated the 8th May 2015 shall be substituted by the following:—

Label Registration fee on all IMFL brands (including FMFL & Wine) received at wholesale depots (January to December of preceding year) per lable per annum for Civil & Defence.

Lable Registration fee on all Beer received at wholesale depots (January to December of preceding year) per lable per annum for Defence.

(a)	Up to 500 Cases per annum	Rs. 5,000
(b)	From 501 to 1,000 Cases per annum	Rs. 7,000
(c)	From 1,001 to 1,500 Cases per annum	Rs. 10,000
(d)	From 1,501 to 2,000 Cases per annum	Rs. 15,000
(e)	Above 2,001 Cases per annum	Rs. 18,000

Lable Registration fee of C.S. in glass bottles shall have Rs. 22,000 per annum:

Provided that the application for registration of lables shall be, besides the Bank Draft equivalent to the requisite fee as prescribed, accompanied by a separate Bank Draft/Chalan showing payment of Rs. 25,000 towards application fee for lable registration (Beer per brand for Civil) & Rs. 10,000 towards application fee for lable registration (Beer per brand for Defence), Rs. 22,000 towards application fee for lable registration (IMFL/Wine/FMFL per brand pack size for Civil/Defence) and Rs. 16,500 towards separate lable registration fee for export of IMFL/Beer (per item/brand).

The Amendment shall come into force with effect from 1st April 2016.
