S. R. O. No. 110/2017—Whereas, the poll was countermanded during last General Election to PRIs, 2017 due to death of contesting candidate in respect of Panchayat Samiti Member of Badagaon Gram Panchayat under Balikuda Block in Jagatsinghpur district.

Now, therefore, the State Election Commission, Odisha, in exercise of power conferred under Article 243-K of the Constitution of India and other enabling powers under Odisha Panchayat Samiti Act, 1959 and Odisha Panchayat Samiti Election Rules, 1991 is pleased to order that fresh election in respect of Panchayat Samiti Member of Badagaon Gram Panchayat under Balikuda Block in Jagatsinghpur District where election was countermanded shall be held as per the following programme :—

The Act/Rules referred to above are as prescribed in the Odisha Panchayat Samiti Act, 1959 and Odisha Panchayat Samiti Election Rules, 1991.

1. The model code of conduct issued by the Commission will remain in force from this date i. e. the 14th March 2017 till the 19th April 2017 in the concerned Panchayat Samiti Constituency.

2. The nomination of contesting candidates except the deceased whose name have been published under Rule 11(14) on the previous occasion i. e. on the 19th January 2017 during last General Election to PRIs, 2017 shall remain valid. They shall not file nominations again and they shall be intimated about the election schedule.

3. Withdrawal of candidature is only permissible for those candidates who are going to file nomination during this period.

4. Allotment of symbol shall be done afresh in Odia alphabetical order.
