NOTIFICATION

The 27th November 2020

S.R.O. No. 256/2020—In exercise of the powers conferred under Section 33 of the Odisha Forest Act 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village Lulkidihi under Balisankara Tahasil in the district of Sundargarh mutated and transferred in favour of Forest & Environment Department for the purpose of raising compensatory afforestation thereon against the proposed diversion of 3.93 Ha. of forest land out of total project area of 158.418 Ha for expansion of project within Kamanda Steel Plant in Bonai Forest Division by M/s Rungta Mines Ltd. vide in-principle approval Order No.5-ORB410/2020-BHU, dated the 5th March 2020 of Government of India, Ministry of Environment, Forests & Climate Change, Eastern Regional Office, Bhubaneswar under Section 2 of the Forest (Conservation) Act 1980, the limits of which are specified below and the area of which is 5.01 Ha. (12.379 acres), shall be Protected Forests with effect from the date of issue of the Notification and shall be known as “Lulkidihi Protected Forest”.
