No. 5800—TPS-Planning-39/2015-BDA.—As required under sub-section (3) of Section 23 of the Odisha Development Authority Act, 1982, notice is given that Bhubaneswar Development Authority has declared its intention vide Resolution No. 22/132, dated the 20th February 2016 to make a Town Planning Scheme in respect of the area (comprising parts of village Shampur and Malipada under the Development area of Bhubaneswar Development Authority) bounded by starts from West to East side of adjoining Plot such as 147, 1138, 149 of village Malipada and 342, 338, 336, 687, 1214, 1236, 699, 700, 701 of village Shampur in the North, starts from East to West side adjoining plot such as 822, 1277, 821, 811, 813, 607, 606, 534, 612, 615, 616, 617, 618, 481, 375, 376, 1185, 372, 371, 356, 357, 359 and 360 of village Shampur and 181, 221, 222, 223 and 216 of village Malipada in the South, starts from North to South side adjoining plot such as 782, 781, 780, 750, 751, 748, 752, 1116, 764, 765, 767, 768, 806 and 824 of village Shampur in the East, and starts from South to North side adjoining plot such as 210, 235, 237, 169, 168, 167, 166, 163, 162, 161, 156, 154, 153, 152 and 146 of village Malipada in the West.
