RESOLUTION

The 3rd March 2019

Subject—Restructuring the carder of the Odisha Engineering Service.

The matter of streamlining the Odisha Engineering Service Cadre structure was under consideration of the Government for some time in order to mitigate the increasing work load in various Engineering Departments, the stagnation in promotion and the resultant erosion in productivity. The Cabinet in their 70th meeting held on 26th February 2019, decided to restructure the Odisha Engineering Service Cadre as follows:—

- 1. The total number of sanctioned posts of Engineering Service Carde remains unchanged at 3130 as before. Out of which the Water Resources Department has 1608, Works Department has 1037 and H&UD Department has 485 sanctioned posts.
- 2. The existing post of Deputy Executive Engineer in the Pay Level-12 has been abolished thereby resulting in the merger in the cadre of AEF & DEE.
- 3. The Existing posts of Superintending Engineer (Level-II and Level-I) are being merged and re-designated as Superintending Engineer in the Pay Level-14.
- 4. A new post in the name of Additional Chief Engineer has been created in between Superintending Engineer and Chief Engineer in the Pay Level-16.
- 5. The Assistant Executive Engineers are to function as Subdivision Head and the Executive Engineers/Superintending Engineers are to function as Division Head. Circles are to be managed by Additional Chief Engineers. The Chief Engineers will remain as the Head of the Department as before.
- 6. All the posts proposed for upgradation covered under the proposal for restructuring shall be filled up strictly on the basis of seniority with exclusion of persons considered unsuitable.

- 7. The existing seven tier cadre structure has been modified to six tier cadre structure.
- 8. The restructured cadre strength of different Engineering Departments under Odisha Engineer Service Cadre shall be as follows:—

- 9. The details of restructuring proposal approved by the Cabinet in respect of Water Resources Department, Works Department and Housing & Urban Development Department have been endorsed to concerned Department.
- 10. This has been concurred in by the Finance Department vide their U.O.R. No. 92 CSI (I), dated the 18th June 2018.
- 11. The G..A. Department has agreed to the proposal of restructuring of OES Cadre in the OSWAS File No. GAD-SC-GCS-0113-2018.
- 12. This will come into force with effect from the date of issue of this Resolution.
