The functions of the Inter-Departmental Task Force are:

- To monitor the segregation of solid wastes at source and transfer & safe disposal of segregated wastes as per extant Rules.
- To ensure that industrial effluents are not led to storm water drains.
- To carry-out survey on the characteristics, quantity of waste generated and advise units on the appropriate system of segregation, creation of containers or containment area within the units.
- To ensure Departmental co-ordination for safe disposal as per extant Rules.
- To seek expert advice as and when required.

Logistics support shall be provided by IDCO.
