No. 16675—SME-FE-OES-0194/2021-SME.—In pursuance of The Odisha Education Service (School Branch), (Method of Recruitment and Conditions of Service) Rules, 2019, the State Government do hereby appoint the following 2 (two) candidates who have come out successful in the Examination conducted by the Odisha Public Service Commission, Cuttack to the post of Odisha Education Service (School Branch) (Group B) in Cell-1, Level-10 of the Pay Matrix under Odisha Revised Scale of Pay Rules, 2017 which is subject to outcome in WP(C) No. 36126/2021, 37613/2021, 39872/2021 & 41629/2021.

They shall be on probation for a period of two years from the date of their joining in the post subject to fulfilment of the conditions laid down under these rules and their appointment is subject to verification of character and antecedents and verification of original certificates. On receipt of adverse report on character and antecedents his/her services shall be terminated forthwith in accordance with the provisions laid down in sub-clause (ii) of Clause (h) of Explanation under Rule 13 of the Odisha Civil Services (Classification, Control and Appeal) Rules, 1962, reinforced in G.A. Department Resolution No. 34438, dated the 20th November 1999. The candidates shall join in their assignment within 30 days from the issue of this notification failing which the offer of appointment shall be cancelled.

On being appointed to Odisha Education Service (School Branch) (Group B) the candidates are hereby posted as Block Education Officer/Headmaster mentioned against their names :—

The candidates are instructed to furnish the following documents in original to the concerned District Education Offices at the time of joining for verification :—

- i. Medical Fitness Certificate from competent authority.
- ii. Two Character Certificates issued by two different Gazetted Officers.
- iii. A declaration to the effect that no criminal antecedent/case is pending against him/her.
- iv. Oath of allegiance to the Constitution of India.
- v. Declaration of non-contract of plural marriage.
- vi. Caste Certificate (if candidate belongs to ST/SC/SEBC).
- vii. Disability Certificate.
- viii. Sports Certificate.
- ix. Two self-attested passport size photographs.
- x. Original certificates in support of Educational Qualifications.
