No. 13136—DAFE-AFE-FE-0130/2022-Ag.& F.E.—The following Agriculture District Officers (ADO)/ Deputy Director of Agriculture (DDA) are promoted to the rank of Chief District Agriculture Officer (CDAO)/ Joint Director of Agriculture (JDA) Level-II on *ad hoc* basis in the Pay Scale of Level-13 of Pay Matrix under O.R.S.P. Rules, 2017 for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officer, whichever is earlier. This *ad hoc* promotion is subject to the concurrence of the OPSC on their earlier *ad hoc* promotion to the rank of ADO/DDA. If the OPSC do not agree to concur with the earlier *ad hoc* promotion of any of the following officers, they will be reverted to the lower grade of the cader.

Such promotion shall be subject to final outcome of W.P (C) Nos. 16909/2016, 16911/2016, 16622/2016 & 16376/2016 and other related cases, if any.
