S.R.O.NO.-100/2021.— In exercise of the powers conferred by sub-clause (d) of clause (8) of Section 2 of the Official Secrets Act., 1923 (19 of 1923), read with notification of the Government of India in the Ministry of Home Affairs No. F-21/20/62 Poll (I) dated the 4th May, 1963, bearing No. S.O. 1284, published in the Gazette of India, dated the 11th May, 1963, Part II, the State Government do hereby declare the Repeater-*cum*-Catholic Protection (RCP) and Sectionalizing Motor operated Valve (MOV) stations of Paraip-Raipur-Ranchi Pipeline of Indian Oil Corporation Limited (IOCL) situated at villages Jakub, Badahula, Kandarmunda and Ghosar in the District of Angul having an area of Ac. 0.510 Decs., Ac 0.494 Decs., Ac 0.350 Decs., Ac 0.240 Decs. respectively as specified in the Schedule below to be prohibited place for the purpose of the said Act.
