#### **NOTIFICATION**

In exercise of the powers conferred under Section 33 of the Orissa Forest Act 1972 (Orissa Act 14 of 1972), the State Government do hereby declare that the following land situated in Village–**Podadihi** under Banspal Tahsil in the District of Keonjhar mutated and transferred in favour of Forest & Environment Department for raising compensatory afforestation purpose thereon against the proposed diversion of 120.838ha of forest land within total allotted 139.165ha for Ghoraburhani-Sagasahi Iron Ore Block of M/s Essar Steel India Ltd. vide in-principle approval order No.8-55/2018-FC dtd.06.03.2019 of Government of India, Ministry of Environment, Forests & Climate Change, New Delhi under Section 2 of the forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 120.838ha (298.565 acres), shall be Protected Forests with effect from the date of issue of the Notification and shall be known as "**Podadihi Protected Forest**".
