Further, the Director, Blood Safety is hereby declared as Nodal Officer for National Sickle Cell Mission.

The Roles and responsibilities of the Nodal Officer for National Sickle Cell Mission are mentioned below:—

1. Convene the state level Sub-committee meeting
2. Prepare plan for universal screening
3. Identify and support Centers of Excellence in the States
4. Prepare the budget by allocating financial resources from NHM PIP, leverage grants from MoTA, Ministry of AYUSH and State EFC.
5. Monitor and review of the Sickle Cell Mission Programme on regular basis.
6. Co-ordinate with other stakeholders for smooth operationalization of the programme.
7. Co-ordinate for integration of existing vertical programmes along with the National Sickle Cell Mission and maintenance of data.
8. Develop detail State specific SOP by integrating all three programmes and for Thalassemia.
9. Work out on the teleconsultations concept for the SCDs/Thalassemia along with Medical Colleges, CMC, Vellore and Centre of Excellence.
