No. 1770—Ele(GP)-10/2016-SEC.—Whereas, the State Election Commission had notified the by-election schedule to fill vacant post of Sarpanch of Padmabati Gram Panchayat under Bhapur Block in Nayagarh District along with other offices vide Commission's Notification No. 5203, dated the 23rd December 2015. The date of poll was fixed to the 5th February 2016 ;
