S.R.O.No.103/2021.— In exercise of the powers conferred by sub-clause (d) of clause (8) of Section 2 of the Official Secrets Act., 1923 (19 of 1923), read with notification of the Government of India in the Ministry of Home Affairs No. F-21/20/62 Poll (I) dated the 4th May, 1963, bearing No. S.O. 1284, published in the Gazette of India, dated the 11th May, 1963, Part II, the State Government do hereby declare the Repeater *cum* Cathodic Protection (RCP) and Sectionalizing Motor Operated Valve (MOV) stations of Paraip-RaipurRanchi Pipeline of Indian Oil Corporation Limited (IOCL) situated at villages Rumabahal, Laing and Kudabeda in the District of Sundargarh having an area of **Ac 0.61 Decs, Ac 0.31 Decs and Ac 0.42 Decs** respectively as specified in the Schedule below to be prohibited place for the purpose of the said Act.
